#### 112/21-22 ITEM 4 TO CONSIDER MATTERS ARISING FROM THE DECEMBER 2021 MINUTES

#### Minute 101/21-22 Matters Arising from the November Minutes

**Hedge Cutting Canola** - the Clerk was still trying to obtain a quote for the hedge and also the small copse of trees on the edge of the common off Heol Canola, which is the council's responsibility.

Spare selection boxes - no replies before Christmas.

**Comfrey and Raised Beds** - a quote of £185 had been received for the comfrey treatment/removal. The contractor was having difficulty getting quotes for the wood for the raised beds and will continue to pursue.

**Cemetery** - still waiting on a response from BCBC. Councillor D Lewis was also waiting on a response regarding the dropped kerb.

**Ray of Light** - no response received from this organisation regarding the council's request for numbers helped in the 3 wards.

## Minute 102/21-22 Mayor's Citizenship Awards 2022

No nominations received to put forward.

## Minute 103/21-22 To Set the Precept for 2022/23

Precept - requested from BCBC and acknowledgement of request received.

**Library** - Information ref. footfall at the library recirculated to Members. Asked Richard regarding plans for promotion.

## Minute 105/21-22 Clerk's Report

Cattle Grid Removal - Councillor J Lewis has made a referral to the SW Trunk Road Agent.

<u>Resolved:</u> All information was noted. The quote for the comfrey treatment/removal was accepted and the Clerk was authorized for the work to be carried out. Councillor M John suggested a local supplier to try for the raised bed sleepers. Councillor D Lewis will take the spare selection boxes to the Food Bank. It was agreed that the financial request from Ray of Light would be deferred to the March meeting, giving the charity time to respond to the council's request regarding numbers.

## 113/21-22 ITEM 5 TO RECEIVE THE CRIME FIGURES FOR OCTOBER 2021

It was noted that around 50% of the crime in Sarn is associated with McArthur Glen and the petrol station at Sarn Services.

It was also noted that there was an ASBO on the Green in Sarn. There had previously been issues In this area and the benches had been removed. The benches have now been reinstalled and it was agreed that Members should keep a watchful eye in this area to see if crime rises.

#### <u>Resolved:</u> The information was noted.

#### 114/21-22 ITEM 6 CHRISTMAS 2022

Provision and dates for Christmas 2022 were discussed.

<u>Resolved</u>: The Clerk was given authority to purchase more motifs/lights for Sarn and Bryncoch in line with the budget set in the precept to make the most of any sale purchases early in the year. It was also unanimously agreed that the Clerk would co-ordinate the Christmas 2022 provision and decide on lighting up dates.

The Clerk had circulated a few documents regarding the jubilee. The Clerk would investigate any possible funding available and the Green Canopy scheme would be discussed further.
